1)	Registration Fee	Rs. 2,000/- (80% of Rs. 2,500/-) per candidate at the time of admission
2)	Student Welfare Fund	Rs. 50/- per student per annum
3)	Processing Fee	Rs. 300/- per student at the time of admission
4)	Common Services Fee	Rs. 2,000/- per student per annum
5)	Inter University Tournament Fee	Rs. 60/- per candidate per annum
